Anti-abortion laws & Church ethos in hospital responsible for medieval treatment of Savita Halappanavar

he tragic news of the death of Savita Halappanavar following a decision by consultants at Galway University Hospital not to proceed with the termination of an unviable foetus is a scandal which points to the need for the pro-choice movement to go well beyond legislation on the X case and to put the demand for free legal and safe abortion on demand centre ' stage in an active struggle that needs to be brought into every community and workplace in the state.

Savita Halappanavar developed septicaemia from E Coli after she was refused a timely termination of an unviable miscarrying 17 week-old foetus. She went through days of agony to which one would not subject animal

Despite her persistent pleas, she was denied a termination because there remained a foetal heart beat and according to her husband she was told that we 'live in a Catholic country'. As the discussion around Savita's death has progressed today it is emerging that she would have probably received a termination in a number of other hospitals in this state. This demonstrates the ongoing role of the Church on hospital boards of management. Today in the Dáil, Joe Higgins TD has demanded that a HSE directive be immediately issued to all hospitals demanding that all requests for termination by women whose life OR health is at risk be met on demand. In this sense we must push beyond leaislating for X given that the Supreme Court ruling only allows for termination when the life and not the health of the woman is endangered.

TEXT TO JOIN 087 2995484 This medieval state of affairs persists because of the cowardly inaction of successive governments since 1992 as well as the lethal foot dragging by this government who voted down a United Left Alliance backed bill legislating for X as the maximum reform obtainable from the Dáil.

The government will feel the pressure over this event today and in the coming days. They will hope that the anger and horror will dissipate. It is the role of the pro-choice movement to sustain and organise the developing mood and consciousness among wider and wider sections of ordinary people so that we can go all the way

on achieving genuine choice.

Genuine real choice also means consistently opposing austerity p o l i c i e s , many of which have an greater effect on women.
